**Bid Acceptance Contract**

Friends of Brazoria Wildlife Refuges (FOBWR) is pleased to accept your bid of \$102,000 submitted on August 22, 2013 for the removal of an existing culvert crossing across Bastrop Bayou in the Dow Woods Unit of the San Bernard National Wildlife Refuge, and for the construction of a new culvert crossing at the same location.

This bid was solicited by FOBWR on behalf of the United States Fish & Wildlife Service, Texas Mid-coast National Wildlife Refuge Complex, San Bernard National Wildlife Refuge.

This contract requires work to be completed as described in the detailed Request for Proposal (RFP) for Dow Woods Crossing TNCBWRC-RFP-DWC-2013 and the accompanying drawings.

It is agreed that the payment schedule as outlined in the above RFP shall be modified to accommodate your requirement for the upfront cost of the culverts, to wit, the cost of the culverts and one third of the remaining bid upon execution of the contract:
