I'm glad we're able to at last celebrate the closing of the Brothers River Ranch parcel, and its conveyance to the US Fish and Wildlife Service as the newest protected land within the San Bernard National Wildlife Refuge.

Your support of the work of the Trust for Public Land has been and is deeply appreciated. I'm very grateful for your offer of assistance in offsetting the unexpected cost of debris removal from the site. You'll recall in the process of removing two household debris piles from the property, a third pile was also located. The Trust for Public Land contracted for the removal of the debris with AAA Cheap Trash Hauling of Richmond, Texas.
